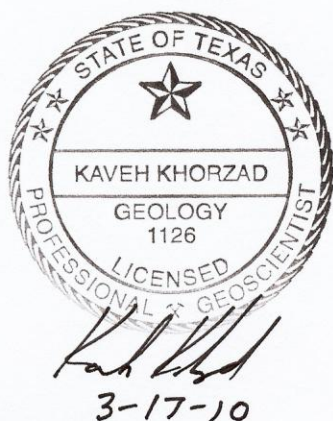

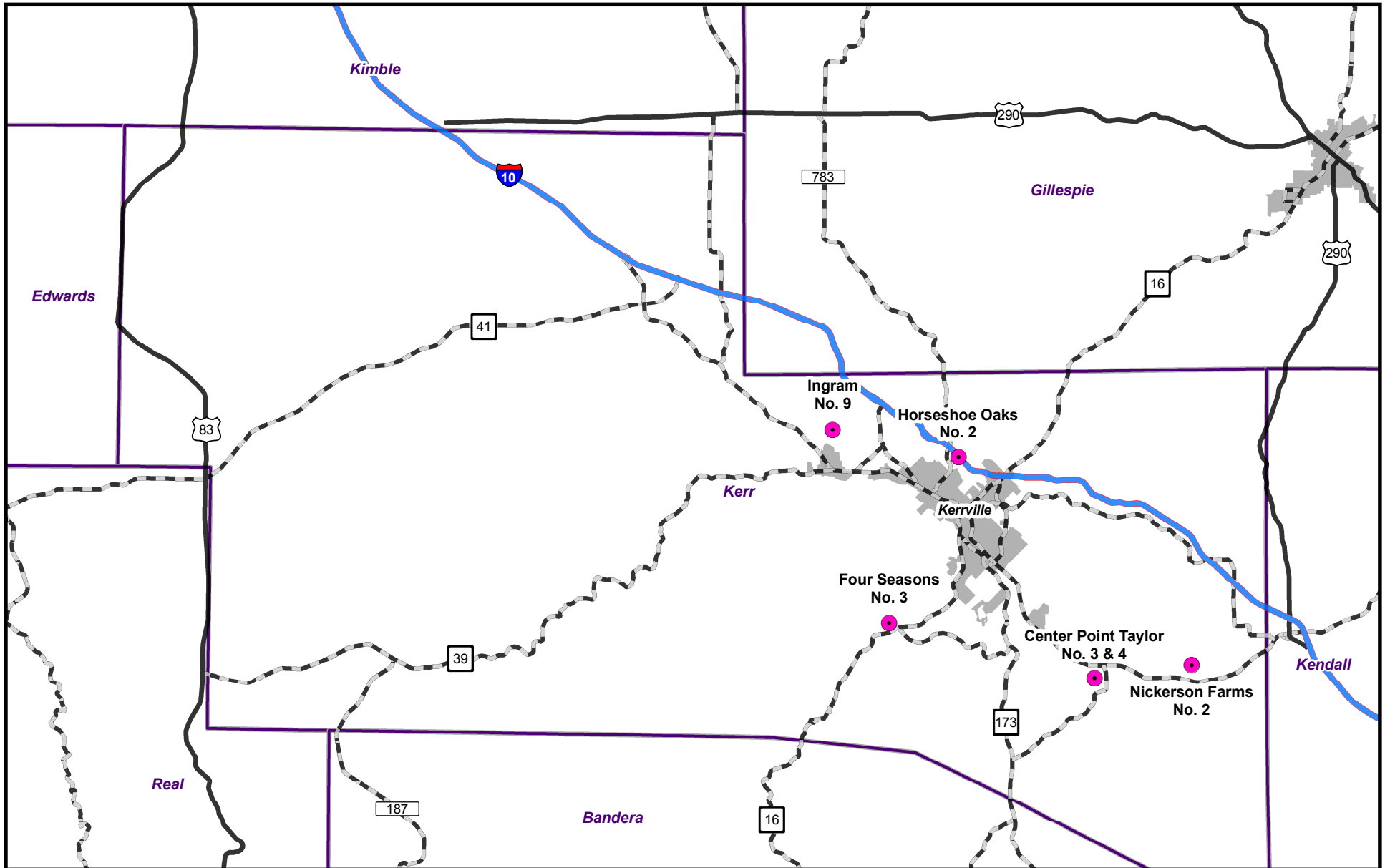

Well Location Map



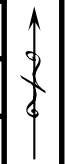

Log Plot: Nickerson Farms No. 2





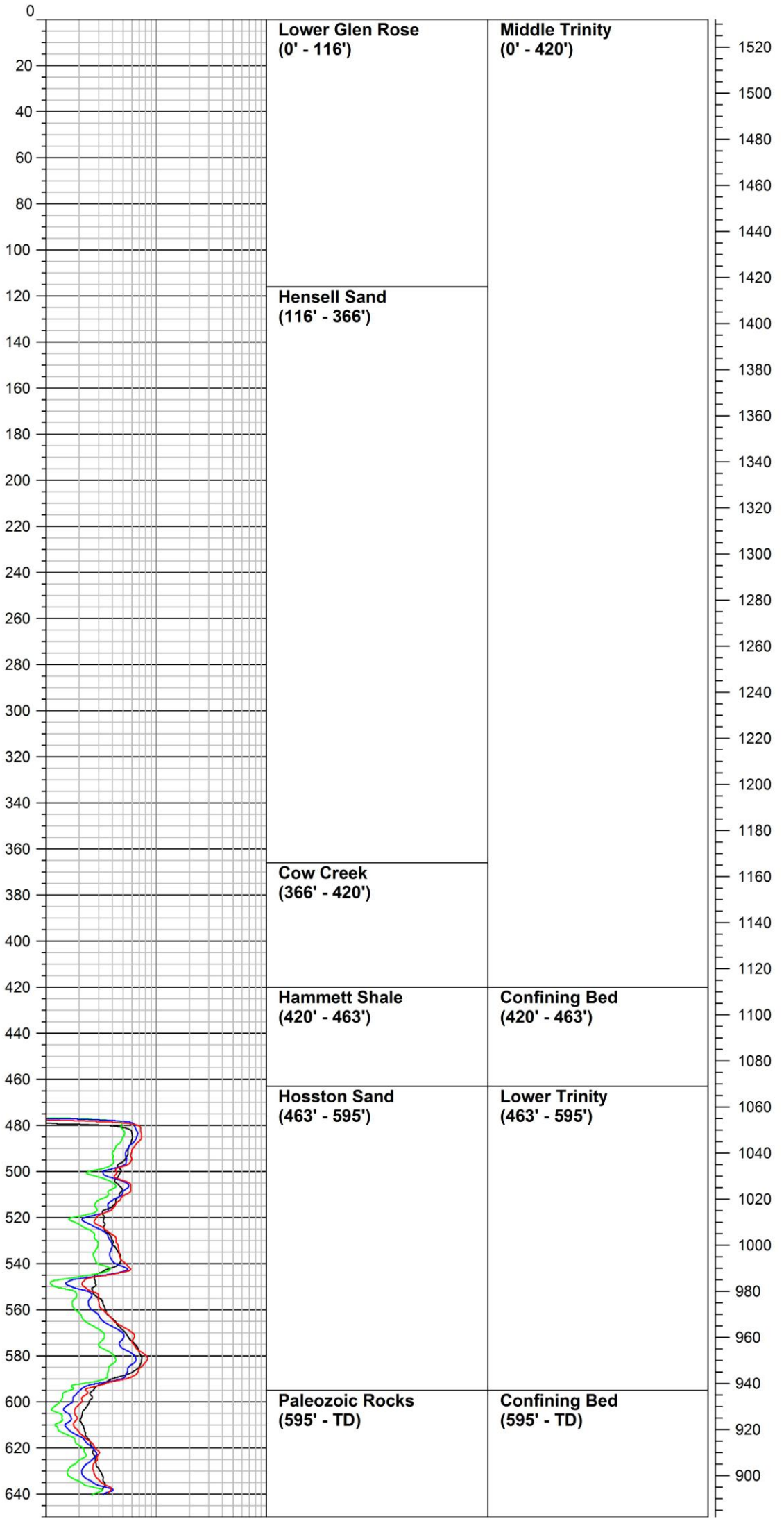
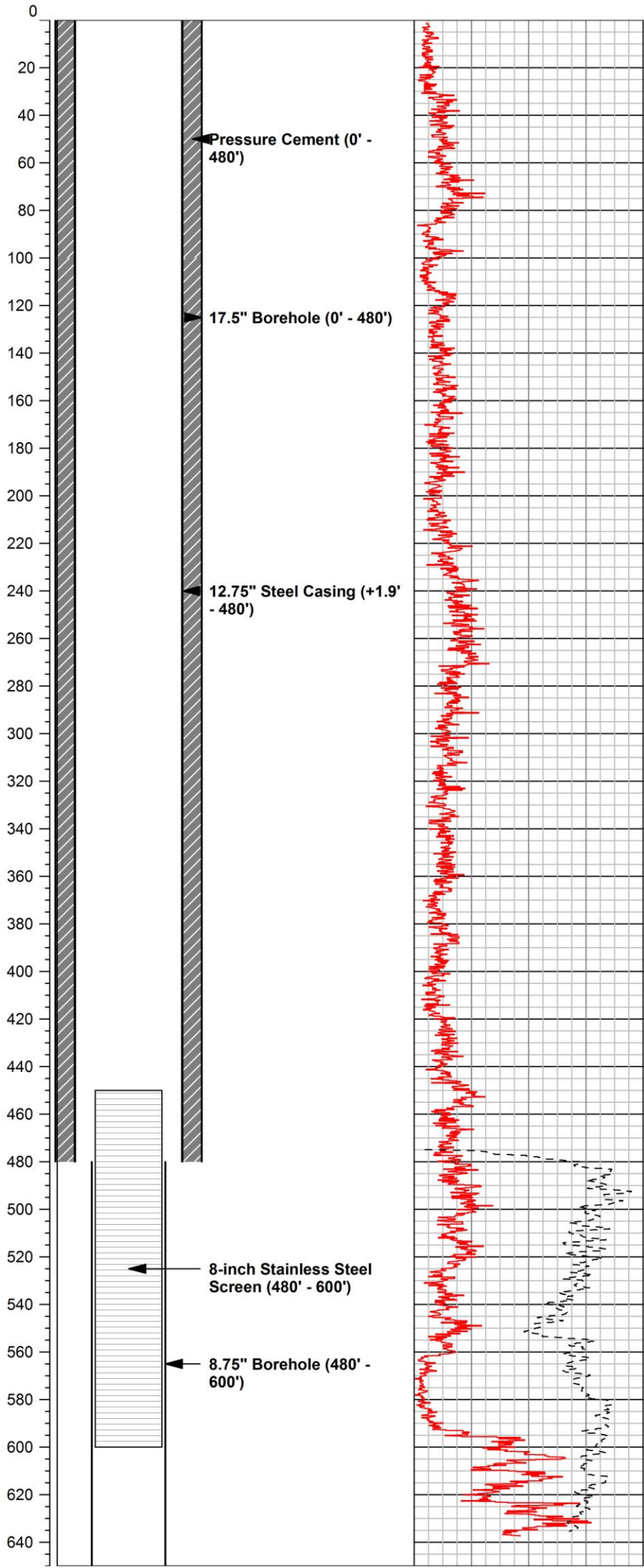
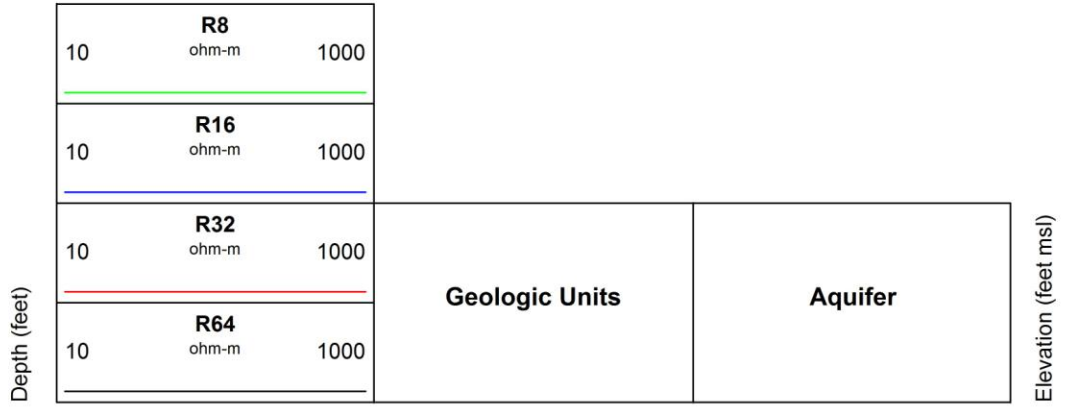
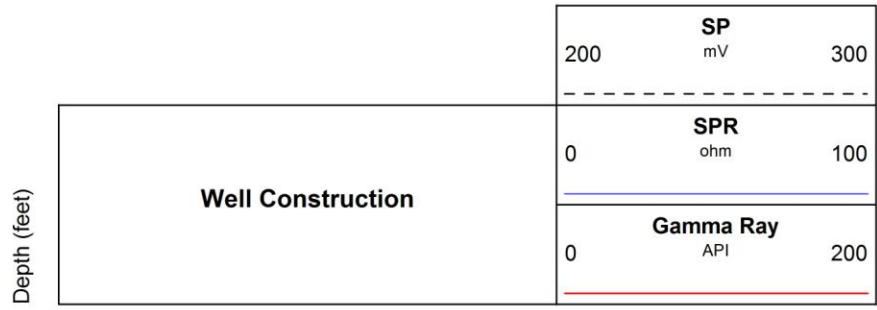

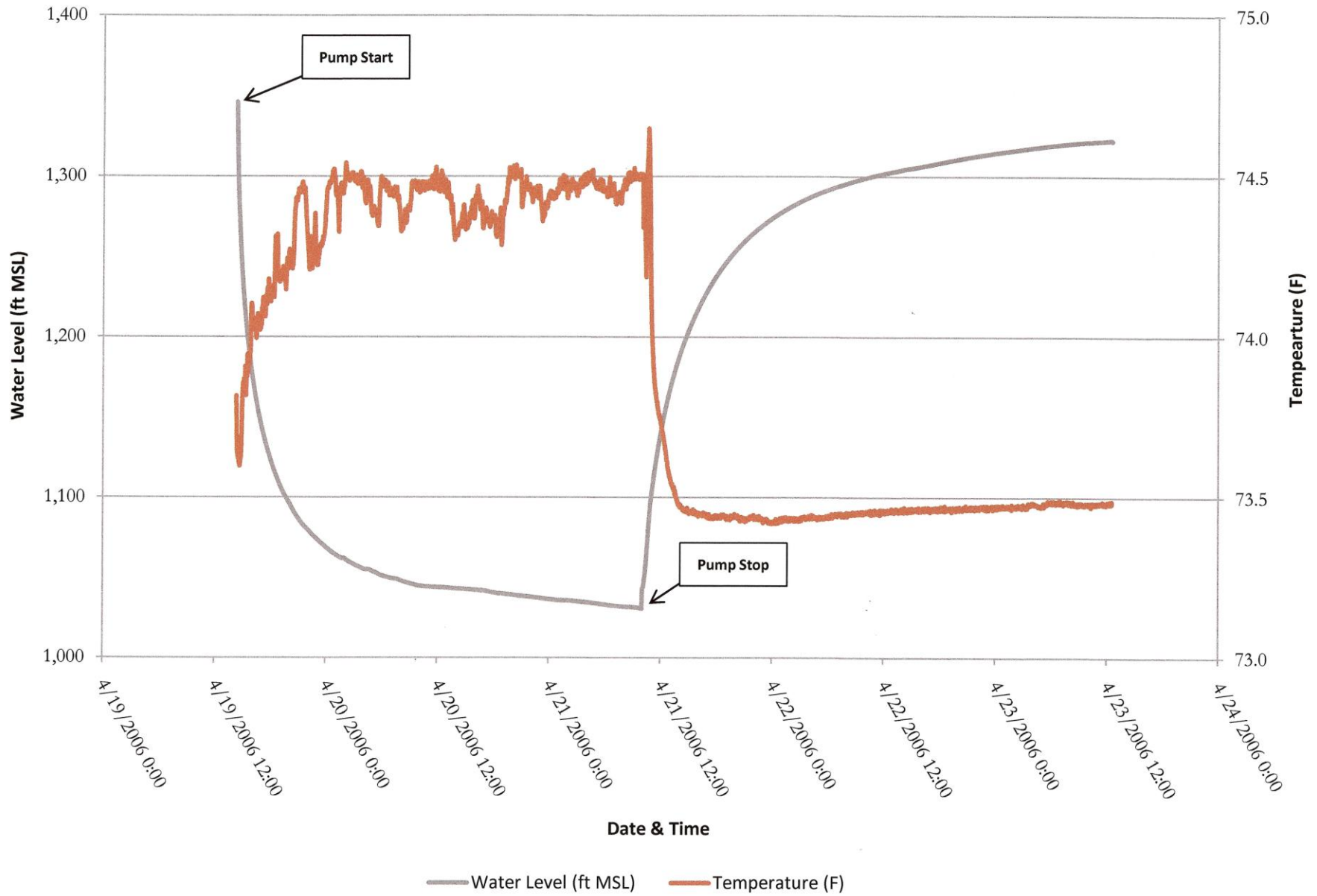
